

# **Objectives**

The objective of the workshop is to provide the necessary knowledge on management verifications and to train the responsible bodies and staff to effectively transfer the key information to their controllers - the "train the trainer" part. The workshop takes a practical, problem-solving approach, primarily aimed at facilitating information exchange, sharing experiences, best practices, and lessons learned from management verifications. We will focus on verifying expenditures reported on a real cost basis, expenditures reported through simplified cost options (SCOs), and the verification of public procurement, irregularities, and financial corrections.




#### **Practicalities**
