Outline

NDICI funds are granted to Interreg external cooperation programmes – they allow for truly and tangibly supporting the participation of neighbouring third countries and regions in cooperation projects, thus reinforcing regional integration and providing concrete responses to shared challenges, especially in border areas with an external dimension.

In the 2021–2027 period, two Outermost Regions programmes (Madeira-Azores-Canarias and Indian Ocean) under Interreg Strand D are making this experience a reality, as NDICI funds have now been allocated to them and they are preparing to launch their first calls. This took several months in the making to reach that important step, and obviously still a lot of questions remain to be answered as we are heading towards the implementation phase. Fortunately, other programmes – namely Interreg NEXT and IPA – have already overcome these challenges, developed and tested this approach successfully in previous programming periods.

This workshop aims to build on their valuable experience. It offers an opportunity to share key lessons and practices in managing NDICI funds, supported by Interact and TESIM. Together we will explore guidance and clarification needed on the relevant regulatory framework and practical implementation.

The event will prioritise open discussion and exchange, offering all participants the chance to ask questions and share experiences. The knowledge exchanged will help shape an adapted and efficient model for NDICI in indirect management, to be trialled in this period by the two programmes and to serve as basis for reflection of a wider implementation NDICI funds in OMR programmes in post-27.

All OMR programmes are therefore warmly invited, as they also have past experience managing external funds, and the discussions would be relevant in all context.

The event will be hosted by the Managing Authority of the Interreg NEXT Black Sea Basin programme in Bucharest, in-presence attendance is recommended to favour meaningful exchanges, but the option to join remotely via an online link is available.
