









- We applied:

 - A unified standard hourly rate defined for each participating country.
 - And the **flat rates for the most time consuming expenditure** to verify.
- **Resulting from:**
 - A fair calculation based on historical data of the previous Programme, and
 - Off-the-shelf options from the regulation.
