Working group specifications

Overview and purpose

In May 2024 Interact started working on an activity to pilot cooperation between programmes to support more impactful evaluations, and to facilitate exchange on perspectives and methods of evaluation in Interreg. Through the early meetings, a series of pilots were started, which enable a more specific exchange between specialisms within Interreg.

These pilot groups were not formally constituted as working groups, rather a continuation of ongoing activities aimed at those working extensively with evaluation. However, in order to avoid confusion, Interact publishes the following information to ensure transparency on the composition and purpose of these pilot groups.

Entry criteria

The starting point of the combined work was the Interreg Knowledge Fair, Riga, 2024, which launched the activities. Each of the pilot groups formed and followed up on the work. This was done bottom-up and not set in a top-down strategy.

The pilot groups have now been working for more than 1 year and have had several meetings. Participation in each pilot group requires a commitment of time and effort, not just attending the meetings, but investing in the work and output.
