Communication & Visibility Approach

Art. 8(3)(e) ERDF / Art. 22(2)(e) NRPP

(ERDF) Each Interreg Chapter shall:

• set out clear arrangements for the envisaged approach to information, **communication and visibility** in line with the rules laid down in Regulation xx[Performance Regulation];

(NRPP) The NRP Plan shall:

(e) set out clear arrangements for the effective monitoring and implementation of the Plan by the Member State concerned, including, the envisaged approach to communication and visibility,....



Communication & Visibility

EU Reference

Art. 18(3), Annex V Performance



- (1) Acknowledgement of the funding
- (3) Obliges the use of the **emblem of the Union** including a **funding statement**..
- ...investment exceeding EUR 100 000, durable **plaques or billboards** that are clearly visible to the public and that present the emblem of the Union and the funding statement.

Annex V lays out the use and technical characteristics of the emblem of the Union ('the emblem') and the funding statement



Communication & Visibility Website

Art. 18(5) Performance/ 64 (1) (2) NRPP

Member States shall ensure information, communication and visibility of support and achievements of the Union funds, and communicate to citizens through the website in accordance with the requirements set out in this Article,...

Setting up a website within 6 months of the adoption of the Plan, publication of the data collected, updated every 6 months (NRPP)



Communication & Visibility Coordinator

Art. 18(6) Performance

(6) Member States shall appoint a **communication coordinator** who shall be responsible for the overall information, communication and transparency actions in relation to the support received from the budget implemented within their territory, ensuring ... **The Commission shall maintain the network comprising communication coordinators** and Commission representatives to exchange about information, communication and visibility activities.



Communication & Visibility MC duties

Art. 56 NRPP

(1) The monitoring committee shall examine:

. . .

(e) the implementation of information, communication and visibility actions with regards to reforms and investments and other interventions included in the chapter;

(2) The monitoring committee shall approve for the chapter(s) under its responsibility:

. . .

(d) the communication strategy



Communication & Visibility Miscellaneous

Art. 18 Performance

- (1), (2) Responsibilities of beneficiaries
- (4) The Commission shall implement information, visibility and communication actions and campaigns...
- (7), (8) Visibility of external actions and communication activities in third-party countries

NRPP Art 63 – Data collection and transparency



Communication & Visibility Major changes

- Communication officers' function for a chapter (programme) is no longer a requirement.
- The XX% financial corrections for breeching visibility requirements is discontinued.
- No mention of visibility for Operations of Strategic Importance.
