

# Summary of Interact IV Monitoring Committee meetings

Updated January 2026

## MC01 – first Monitoring Committee meeting

20 September 2022, Online meeting held under the French Presidency

After more than three years of preparatory work, European Commission has adopted Interact IV 2021-2027 programme on 27 July 2022. The next step was for the Interact IV Monitoring Committee to meet and approve all necessary documents for the successful launch of activities, which is planned for 1 December 2022.

The online meeting was held under the French Presidency and was therefore chaired by Christina Bezes-Feldmeyer. All meeting documents were already discussed before by the Interact IV Programming committee and updated based on the comments and suggestions received.

The monitoring committee approved its Rules of Procedure, the Rules on Eligibility of expenditure, and agreed on the final text of the Strategic Implementation Document. The budget for all beneficiaries (Interact Offices in Valencia, Viborg, Vienna and Turku and Interact Secretariat) and the breakdown of the flat rate for technical assistance were also approved during the meeting. Following the good practice from the past, the spending will be regularly monitored by the Managing Authority and if needed, the budget will be reallocated between the beneficiaries.

## MC02 – second Monitoring Committee meeting

15-16 December 2022, Paris, France

The second Interact IV Monitoring Committee meeting was chaired by Christina Bezes-Feldmeyer and the main item on the agenda was the work plan for 2023.

Interact priorities for the upcoming year are to support Interreg programmes in preparation and start, especially in how to prepare management and control system description, how to switch to risk based management verifications and to comply with the e-cohesion by further developing the Joint electronic monitoring system (Jems). We will also support the closure activities of the 2014-2020 programming period, facilitate the synergies between programmes, be active in the external cooperation (Interreg IPA, Interreg NEXT and outer-most regions) and continue the horizontal support to macro-regional strategies. Our work on harmonisation and simplification will continue as well, as well as the capitalisation activities and strategic visibility,

i.e. Interreg Day Campaign and Interreg Slam. Monitoring Committee members approved the work plan, the upcoming events are available on our website: <https://www.interact-eu.net/events>

Monitoring Committee members also discussed extensively the new element in our work, the training schemes. This new way of learning will enable participants to get comprehensive knowledge and obtain a certificate. Interact will also develop a catalogue of different trainings. First training should be available before summer break.

During the meeting, participants discussed also about the principles of establishing and maintaining Interact networks and working groups, the preparation of the evaluation plan and the preparation of communication strategy.

They gave valuable feedback on all the agenda items and agreed to continue the discussions at the next meeting, which will take place on 30-31 May 2023 in Prague, Czech Republic.

### **MC03 – third Monitoring Committee meeting 30-31 May 2023, Prague, Czech Republic**

The third Interact IV Monitoring Committee meeting was chaired by Milada Hrošková.

At first, Interact presented Interreg Knowledge Fair pilot event, which was a great success.

The meeting continued with programme management updates. During the Interact IV programming period, the Managing Authority will monitor the programme outputs monthly. Risk-based management verification will be mandatory for all programmes in the 2021-2027 programming period. Very low Interact III error rate of 0.04%, which covered minor irregularities related to public procurement, forms a good basis for the new system, which will carry out a sample check.

Next, the members of the Monitoring Committee approved the draft Interact IV Evaluation plan 2021-2027 and commented on the updated Interact IV Communication strategy. Information on the new visual identity for Interact IV, the timeline for the launch of the new website and the visibility of Interact activities was also discussed.

The second meeting day started with the presentation of Interact Academy training programmes and progress details since the last meeting. The participants were also informed about the upcoming changes to the Strategic Implementation Document.

The Monitoring Committee subsequently approved the work plan for the second half of 2023, the upcoming events are available on our website: <https://www.interact-eu.net/events>

The last item of the meeting was devoted to the development and key achievements of the Jems electronic monitoring system. 50 Interreg programmes have already signed the licence.

The next Monitoring Committee meeting will take place online on 5 December 2023 under the Swedish presidency.

## **MC04 – fourth Monitoring Committee meeting 05 December 2023, Online, chaired by Sweden**

The fourth Interact IV Monitoring Committee meeting was chaired by Maria Eriksson from Sweden.

At first, programme management updates were presented. The Managing Authority finalised the Description of Management and Control System in June 2023, prepared several guidance documents for the beneficiaries and controllers and conducted trainings on risk-based management verifications.

Next on the agenda was the state of play of the [Interact Academy](#), a new initiative featuring certified trainings as well as short online courses in programme management, finances, and communication. The participants were also informed about the future changes to one of the key documents of the programme, the [Strategic Implementation Document](#).

After, the members of the Monitoring Committee approved the Interact Work Plan 2024. All upcoming events can be found [here](#). Next, the participants were introduced to the updated Interact IV Communication strategy and the new Interact website, [www.interact.eu](http://www.interact.eu) (launched at the end of 2023). The meeting continued with presenting Interact's new tool, the Interreg Data Exchange (Index). The last item of the meeting was devoted to thematic capitalisation strategy.

The following Monitoring Committee meeting will take place on 11-12 June 2024, in Valencia, Spain under the Spanish presidency.

## **MC05 – fifth Monitoring Committee meeting 11-12 June 2024, Valencia, Spain**

The fifth Interact IV Monitoring Committee meeting was chaired by Carmen Hernandez from Spain.

Day one of the event started with updates on programme management, including performance, staffing, finances and audits. Next, the Monitoring Committee members were updated on Interact IV communication and visibility actions.

Participants also discussed the second version of the Thematic capitalisation strategy and during this session, the French and Italian representatives introduced their respective national initiatives on capitalisation for Interreg achievements. The participants also discussed the second version of the Interact IV Strategic Implementation Document, a key document underlining Interact service delivery.

Afterward, Interact organised a stakeholders consultation workshop in which the Committee representatives were asked to discuss the following questions: What is working? What requires repairing? What is missing? What do you visualise for the future? Each Interreg programme is required to conduct such a consultation that together feed into the preparation of Interreg in the post 2027 period.

The second meeting day started with the presentation of the workshop's outcomes and continued with presenting developments of Jems, the monitoring IT system developed by Interact and

available free of charge for programmes interested and the [Interact Academy](#). Finally, the Committee approved version 2.0 of the Interact Work Plan for 2024. All upcoming events can be found [here](#).

The following Monitoring Committee meeting will be held in Belgium from 27 to 28 November 2024.

### **MC06 – sixth Monitoring Committee meeting, 27-28 November 2024, Louvain-la-Neuve, Belgium**

The sixth Interact IV Monitoring Committee (MC) meeting, chaired by Elena Borghetti from Belgium, brought together committee members for two days of insightful discussions.

On day one, attendees received updates on the usual programme management topics: staffing, programme performance, finances and audits. Furthermore, the state of play of Interact's new IT tools were also presented.

After, Interact's communication manager reviewed communication and visibility actions of 2023 and 2024, emphasising the need to promote the programme and to keep stakeholders informed. This includes Interact newsflash, the new [website](#), and social media. Next, the Committee members learnt about the updated timeline of the programme's operational evaluation.

The [Interact Academy](#) session showed its progress, having an important role in capacity building and knowledge sharing in Interreg. Participants also came back to the updated Interact IV fields of work – introduced at the previous meeting – and the visibility of Interact networks and working groups.

Day one closed with the introduction of the [France-Wallonie-Vlaanderen Interreg Programme](#).

The second day of the event started with a presentation on the results of post-2027 consultations of Interreg and Interact. It provided a short discussion on the outcomes of the [Harvesting event](#).

In the last session, the Monitoring Committee discussed and approved the 2025 work plan of Interact IV. The upcoming events are available on our [website](#).

The Monitoring Committee will hold its next meeting in Budapest from 10 to 11 June 2025.

## **MC07 – seventh Monitoring Committee meeting, 10-11 June 2025, Budapest, Hungary**

The 7th meeting of the Interact IV Monitoring Committee (MC) took place in the historic Gerbeaud Café in central Budapest, Hungary. Chaired by Csilla Szalóky-Hoffmann, members of the Committee gathered to review achievements, share updates, and make key decisions.

The meeting opened with updates on programme management, staffing, finances, and audits. A workshop “MC ways of working” followed, encouraging the participants to reflect on how the MC functions with the aim to make future meetings more effective and engaging.

Interact’s new corporate IT tools, delivered by Microsoft and recently put into use were also introduced, including a live demonstration of the new MC Community SharePoint page. The Committee also discussed proposed changes to the Strategic Implementation Document (SID) focusing on adjustments stemming from the transition to the new IT environment.

In terms of Interact’s communication and visibility, the MC acknowledged the programme’s activities from 2024 until May 2025. The status update and inception report of operational evaluation of the programme was provided by the external evaluators. Preliminary evaluation results will be available at the end of 2025.

Next, the attendees received a report on the [Interact Academy](#). During the presentation, participants were informed that by the end of April 2025, the number of participants reached nearly 600 with nearly 500 certificates awarded.

The last session showcased the ACCESS project, which supports legal accessibility across the Slovak-Hungarian border. This project is an operation of strategic importance (OSI) funded by the Hungary-Slovakia Interreg programme.

On the second day, the redesigned [Interreg.eu](#) website was introduced and welcomed by the participants as a valuable resource for the Interreg community. The next session focused on the future of Interreg and Interact beyond 2027. The Committee agreed to hold an informal online meeting in September 2025 to continue the discussion about the programme’s future.

The meeting concluded with the approval of the updated Interact Work Plan for 2025 (version 2.0), which outlines programme’s key outputs for the year ahead. You can check our upcoming events and trainings on [Interact’s website](#) as well as our publications and other tools delivered.

## **MC08 – eighth Monitoring Committee meeting, 26–27 November 2025, Oslo, Norway**

The 8th meeting of the Interact IV Monitoring Committee (MC) took place on 26-27 November 2025 in Oslo, Norway. Agnieszka Gintowt-Dziewaltowska from Poland chaired the meeting, in cooperation with the Norwegian hosts.

The meeting began with updates from Interact, highlighting recent achievements, including key events like Interreg GO! (March 2025) and the Interreg Knowledge Fair (November 2025), Interreg Cooperation Day events.

Updates concerning the management of Interact as a programme including, finances, audits and staffing followed. Another topic that the Committee discussed was the use of the contributions of the participating countries to technical assistance. As no consensus was reached, MC members agreed to revisit the topic at the next meeting. Updates on communication and visibility activities were also noted. Finally, the Committee approved the updated [Strategic Implementation Document](#) that clarifies Interact's approach to networks and working groups.

The outcomes of the operational evaluation of Interact IV were then presented. It confirmed that Interact's services are valued by programmes and identified areas for improvement in internal processes and governance. The Committee agreed to approve the final evaluation report through a written procedure.

Next, the [Interact Work Plan for 2026](#) was presented and approved. It includes 100 events, 17 certified trainings, and 40 tools to support Interact's main target groups, i.e. Interreg programmes. The plan will be reviewed during the year to ensure it remains aligned with the needs of Interact's target audiences.

Discussions also tackled the future of Interreg and Interact in the 2028-2034 programming period. Updates on ongoing EU-level negotiations were shared, and participants emphasised the importance of coordination and exchange among Member States. The Committee supported the creation of an informal Member State platform, '*Friends of Interreg*', facilitated by Interact, to support dialogue and share draft positions for the next programming period.

In the final session of the event, Committee members had the chance to learn about the new performance-based approaches that shall – based on pre-defined milestones and targets – simplify payments from the European Commission to Interreg programmes in the 2028-2034 programming period.
